Classes:

Gamblers: Consists of two distinct parts. In the first part, the dogs earns points for each obstacle performed correctly (each obstacle may be performed twice successfully). After the whistle blows, the dog can earn bonus points by working away from the handler through a series of obstacles, while the handler stands behind a designated line.

Standard: Includes all obstacles and obstacles must be performed in order and in the time set by the judge

Jumpers/steeplechase: Jumpers is a numbered course consisting of only jumps and tunnels. Steeplechase is a numbered course consisting of jumps, tunnels, aframe and weaves only.

Snooker: Two part course, opening consists of 3-4 red jump and obstacle combos, closing is numbered sequence of obstacles, 60 seconds.

THIS IS A FUN MATCH: Toys, treats, clickers, and collars/leashes are all permitted on course.
